- You have NOT already filed this appeal for the 2022-23 year. **\*\*Only one appeal may be submitted per award year\*\***

Submission of this appeal does not ensure a change or increase to your award. Appeals are reviewed regularly and a Financial Aid Advisor will notify you of the result.
